

Income Tax Charitable Deduction

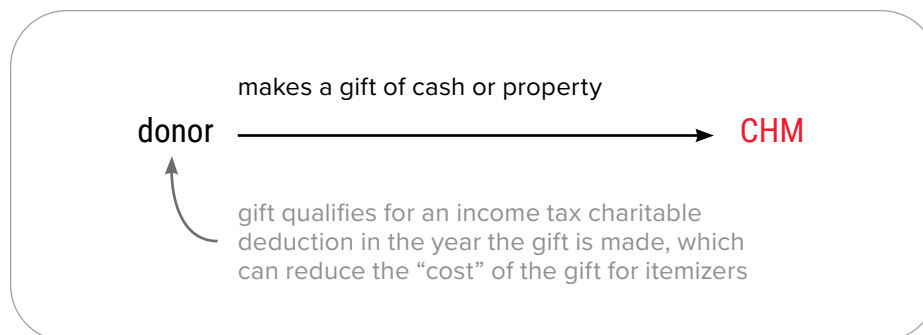
Gifts of money or property to a qualified charity are eligible for a federal income tax charitable deduction in the year the gift is made (subject to limitations). Donors may carry over excess deductions for five years.

Concept applied:

A donor who makes a lifetime gift to a qualified charity enjoys the personal satisfaction of seeing the gift at work, but can also qualify for a tax deduction on an itemized return. Only donation amounts exceeding 0.5% of the donor's adjusted gross income (AGI) qualify for a charitable deduction. Note that for donors in the 37% tax bracket, the tax benefit of their deduction will be capped at 35%.

How it works:

Amanda Garver's cash gift to a public charity is deductible up to 60% of her AGI. The next year, her gift of appreciated stock is deductible at fair market value (FMV) for up to 30% of AGI (or at a cost basis of up to 50% of AGI). The following year, she donates her car and deducts the FMV (with a written appraisal), since the charity will not use the car for its exempt purpose.



Why is it useful?

For a donor who itemizes, a charitable income tax deduction means a smaller tax bill in the year the gift is made, which may allow a donor to make a much larger gift than would have otherwise been possible.
